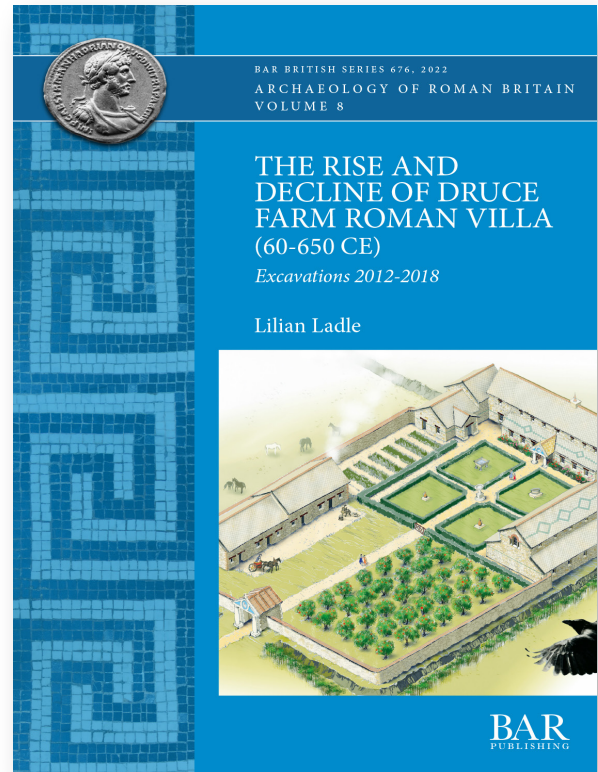

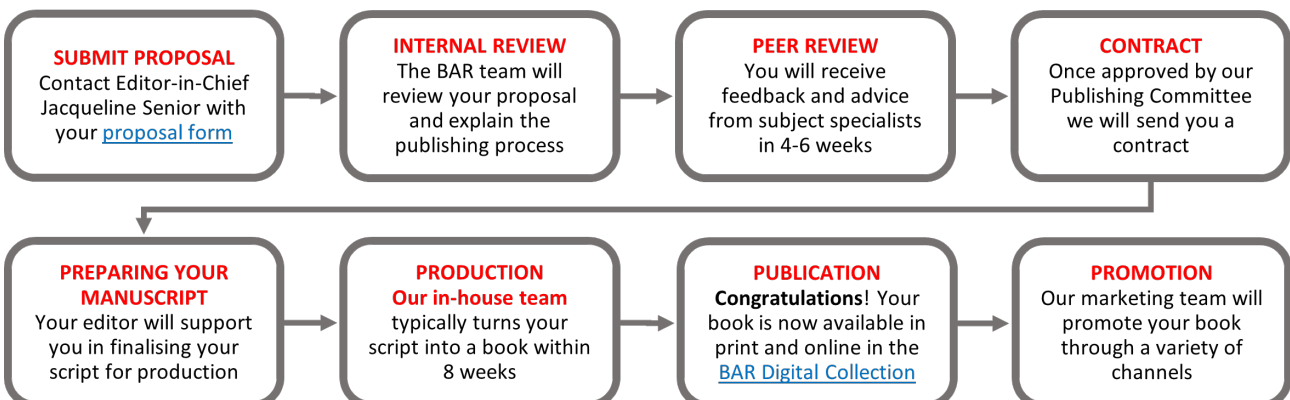

The *Archaeology of Roman Britain* series will consider submissions for publication relating to the Roman province of Britannia, spanning a broad period from the **late Iron Age through to post-Roman Britain** (roughly from the **1st century BC to the 5th century AD**), and also encompassing studies that examine the interaction

between the British Isles, the nearby Continent, and other parts of the connected Roman empire. **Reports, revised doctoral theses, synthetic studies** and **data analyses** are welcome, including research relating to, fieldwork results, material culture, environmental studies, landscapes, numismatics, epigraphy, and historical matter. Books will be published in print and digital format, and in Open Access on request.
